Jerry is Associate Director of the Kentucky Geological Survey. Throughout his 35-year career in the geological sciences he has always been involved in geospatial database creation and software development. His research background is in coal exploration and mining geology, resource analysis, and the application of GIS to geologic problems. He led a team of KGS staff in the development of Web-based data dissemination services and their supporting databases. Jerry has participated in national standards efforts for geoscience information as was a co-author of the data model for an international standard for geologic mapping information – GeoSciML. He has an M.S. and PhD. in Geology from the University of South Carolina with a background in coal geology, mining and resource assessment, and GIS.
